APPLICATION AND USE

Shower heads and hand showers for sanitary tapware according to EN 1112 are intended for use in drinking water systems within the following limits: a dynamic pressure of 50 kPa to 500 kPa and a maximum temperature of 70°C. The recommended limits for correct operation are: a dynamic pressure of 100 kPa to 300 kPa and a maximum temperature of 42°C.

MARKING

The Kiwa®-mark products are marked with the wordmark "KIWA". Place of the mark: on the body.

Compulsory specifications:

- name or mark of the manufacturer "Riobel", on the body;
- indication of the acoustic group, on the body;
- indication of the flow rate class, on the body.

Method of marking:
